

Key Investor Information

This document provides you with key investor information about this Fund. It is not marketing material. The Fund is managed by Gemini Capital Management (Ireland) Limited which acts as manager to the Company

Objectives and Investment Policy

The investment objective of the Fund is to seek to provide absolute growth through a highly diversified portfolio of investments in global fixed income securities, investing in government bonds and corporate bonds with the aim of producing investment returns with a relatively low level of volatility (below 5% over a business cycle).

The Fund is considered to be actively managed in reference to the Federal Funds Target Rate Mid-Point of Range plus 1% (the "Benchmark") by virtue of the fact that it uses the Benchmark for performance comparison purposes. However the Benchmark is not used as a performance target.

The Fund's investment will be made in global fixed income securities that are listed in a recognized and approved exchange and/or market. The Fund's holding range is diversified and it is expected that the actual number of global fixed income securities will be a minimum of 16 securities and may be close to 90 different holdings.

The weighted average credit quality (meaning the credit rating of all of its investments when taken together) of the Fund will be investment grade (i.e. at or above S&P rating BBB – or equivalent). The Fund will also seek to maintain a relatively low level of volatility (meaning that it will seek to invest in securities which historically tend to move in a low fashion in terms of their value) in its portfolio. Part of the exposure to credit may also include a small allocation (a maximum of 20% of the Fund's Net Asset Value) to sub-investment grade securities, but the overall Fund's minimum of BBB- rating will be observed.

The Fund may also invest in fixed income securities which are issued by countries which are less developed in terms of their financial markets (known as emerging markets). A maximum of 20% of the portfolio may be held in fixed income securities that are denominated in emerging market currencies. The maximum that the Fund may invest in Russian securities is 10% of Net Asset Value. The maximum that the Fund may invest in Chinese securities is 10% of Net Asset Value.

The Fund may adopt specialist financial techniques (using instruments known as derivatives, including exchange-traded futures, options and swaps) and may enter into securities lending agreements to manage risk in the Fund and protect the Fund's value should the managers deem that the capital value of its investments may fall, or to manage the Fund more efficiently. The use of derivatives will involve leverage.

The Fund may invest up to 10 % of its net assets in aggregate in other collective investment schemes.

The Company may, at its discretion, declare dividends (i.e. income arising from Shares).

You may buy and sell your Shares on any day on which banks in the United Kingdom and Ireland are open for normal business.

The Fund is categorised as a 3 because it is invested in a broad spectrum of global investment grade and high yield corporate and government bonds.

The following are risks materially relevant to the Fund which are not adequately captured by the indicator:

Credit Risk: There is a risk the bond issuer may fail to meet its repayments. This is usually a greater risk for bonds that produce a higher level of income. Changes in interest rates, inflation and the creditworthiness of the bond issuer may also affect the bond's market value.

Sub-Investment Grade Risk: Investment in sub-investment grade fixed interest securities involves greater price volatility and risk of loss of principal and income than investment in fixed income securities of a higher investment grade quality.

Derivative (financial techniques) Risk: The Fund is entitled to use derivative instruments for efficient portfolio management. Derivatives may not achieve their intended purpose. Their prices may move up or down significantly over relatively short periods of time which may result in losses greater than the amount paid. This could adversely impact the value of the Fund. The Fund may enter into various financial contracts (derivatives) with another party. There is a risk that this party will become insolvent or fail to make its payments which may result in the Fund and your investment suffering a loss. Where the Fund uses futures or forward foreign currency contracts (derivatives), it may become exposed to certain investment risks including leverage, market, mismatching of exposure and/or counterparty risk, liquidity, interest rate, credit and management risks and the risk of improper valuation. While the Fund is not expected to have exposure to leverage to a material degree, any movement in the price of these investments can have a significant impact on the value of the Fund and the Fund could lose more than the amount invested.

Charges

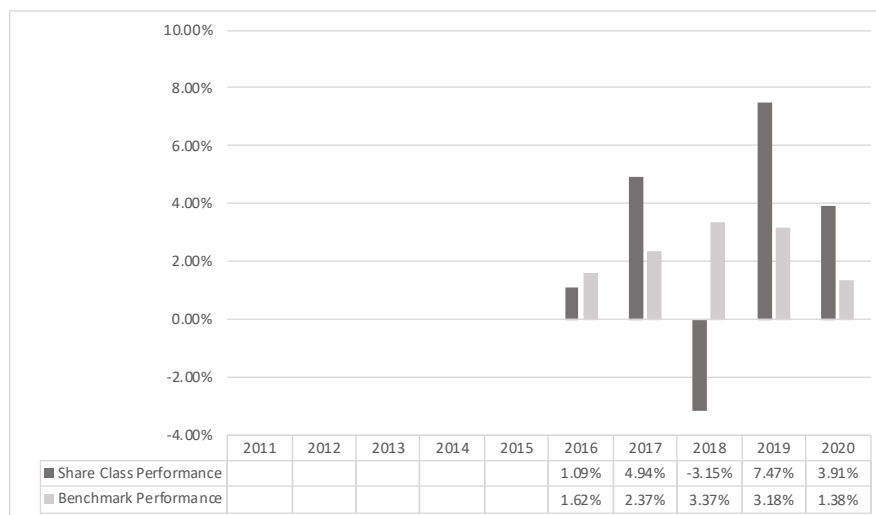
The ongoing charges figure is based on the year ending 31 December 2020 but may vary from year to year.
